- Description should include a 7-word or less headline.

- Submit a product photo.
  - Photo should be a TIF or JPG.
  - Resolution should be 300 dpi at 5"x7".
  - Do not include logos or booth numbers in the photo.
  - Logos will not be accepted as product photo.
