MARKET INSIGHTS REPORT AGREEMENT

RSNA reserves the right to determine the eligibility of each purchaser, and the right to refuse of prohibit purchase at any time. - 2. License Grant; Restrictions on Use; Other.

Under this Agreement, You are authorized only to: (i) download the then-current Market Insights Report from the RSNA website or such other source as designated by RSNA; and (ii) use the thencurrent Market Insights Report for Your internal business purposes, including use in whole or in part in internal reports, internal meetings, and internal presentations. RSNA reserves all rights not expressly granted to You under this Agreement.
- 2.2 Restrictions on Use. Unless You receive the prior written permission of RSNA, You shall not: (a) reproduce, disseminate, publish, or transfer the Market Insights Report or its content in any form or by any means; (b) make any modification, adaptation, improvement, enhancement, translation or derivative work from the Market Insights Report; (c) violate any applicable laws, rules or regulations in connection with Your access or use of the Market Insights Report; (d) remove, alter or obscure any proprietary notice (including any notice of copyright

- 4. Restriction on Transfer. You may not rent, lease, lend, sublicense or transfer the Market Insights Report, this Agreement or any of the rights granted hereunder. Any attempted transfer in contravention of this provision shall be null and void and of no force or effect.
- 5. Term and Termination.
- 5.1 Term. This Agreement shall be effective until terminated.
- 5.2 Termination. Either party may terminate this Agreement, effective on written notice to the other party, if the other party materially breaches this Agreement, and such breach: (A) is incapable of cure; or (B) being capable of cure, remains uncured thirty (30) days after the non-breaching party provides the breaching party with written notice of such breach.Upon the termination of this Agreement, You shall immediately cease all use of the Market Insights Report.

- 9. Miscellaneous.
- 9.1 Governing Law. This Agreement shall be governed and construed in accordance with the laws of the State of Illinois, USA, without regard to its conflict of laws provisions. The parties agree that exclusive jurisdiction for any dispute arising under or related to this Agreement shall be with the appropriate state court in DuPage County, Illinois, USA or in the United States District Court for the Northern District of Illinois, and each party consents to the jurisdiction of such court in any action or proceeding and waives any objection to such venue. Except as provided herein, the failure to exercise a right or require performance of an obligation under this Agreement shall not affect a party's ability to exercise such right or require such performance at any time thereafter nor shall the waiver of a breach constitute waiver of any subsequent breach.
- 9.4 Survival. The following sections of this Agreement and any other provisions of this Agreement which by their express language or by their context are intended to survive the termination of this Agreement shall survive such termination: 1, 2.2, 3, 4, 6, 7, 8, and 9.
- 9.5 Assignment. You shall not assign this Agreement or any rights or obligations herein without the prior written consent of RSNA and any attempted assignment in contravention of this provision shall be null and void and of no force or effect. This Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and permitted assigns.

- 9.6 Entire Agreement. This Agreement including the documents incorporated herein by reference constitute the entire agreement with respect to the use of the Market Insights Report licensed hereunder and supersedes all prior or contemporaneous understandings regarding such subject matter.
