2024 Report of the Secretary-Treasurer

I am pleased to report that RSNA continues to maintain membership at a high level. In FY 2023-2024 the Society accepted 8,755 new members.

We annually promote membership in our Society to new radiology residents and medical students. Through this year's promotional efforts 5,658 radiology residents and medical students joined the RSNA (1,696 new Members-in-training, 3,279 new Corresponding Members-in-training, 307 Fellows, and 376 Medical Students).

We are pleased to see our specialty's future leaders taking advantage of the great opportunities offered to them through RSNA membership. Members-in-training and medical students do not pay membership fees, have free access to RSNA benefits like Online Education, have a substantially discounted admission to the RSNA Scientific Assembly and Annual Meeting, and receive access to all six online journals and the RSNA Legacy Collection.

The financial statements for the fiscal year ended June 30, 2024, reflect positive earnings for the Society.

The Society continues to experience financial growth. This is a result of maintaining its revenue sources and at the same time controlling its expenses. The return on investments is especially important for the Society's Research and Education Foundation, as its ability to fund grants is directly impacted by investment earnings.

FORVIS LLP completed its annual audit of the Society's financial statements issuing an unmodified opinion, indicating that FORVIS LLP found no material differences to the financial information presented in the Society's year-end financial statements. In addition, FORVIS LLP indicated to the Audit Committee that it did not find any material weaknesses in the Society's internal accounting procedures.
