

## Special Interest Session: High Impact Clinical Trials

### High Impact Clinical Trial SESSION:

The upcoming 2018 RSNA Annual Meeting and Scientific Assembly will again host a **High Impact Clinical Trial (HICT) Session** featuring the latest cutting-edge clinical science and research. This session will provide a forum for practice changing clinical research across radiology with the goal to present the most significant work in our field. Each accepted abstract may be considered for *simultaneous* online publication in *Radiology*. For consideration of simultaneous publication, a draft of the manuscript will be needed by September 5 to allow for rapid review.

### Type of submissions to be considered:

- First presentations of the primary endpoint(s) of a trial
- Presentations of new data or secondary analyses of a trial where the primary data have been presented previously
- New Registry or new data/analyses from a registry
- The latest and “hottest” findings in translational imaging sciences that have immediate clinical implications

### Session Format:

Three to five trials will be presented, followed by a discussant, and questions.

### Eligibility

To be considered for this session, the author must submit the following:

- A structured abstract (purpose, methods, results, and conclusions) (500 words maximum, plus optional inclusion of up to two tables and/or three figures)
- Applicants must indicate whether they are interested and able to submit a full draft of the manuscript by September 5. The applicant must submit a signed letter that includes the following items: author name, co-author(s), corresponding address, telephone and fax numbers, institutional affiliation, title of abstract, and a statement attesting to the fact that the research was primarily and substantially performed by the applicant.

### Timeline

- Call for HICT Abstracts: June 1, 2018
- Abstract Submission Deadline: August 1, 2018, 12 NOON CT
- Notifications of acceptance: August 15, 2018
- Manuscript deadline (optional): September 5

### Study confidentiality and Embargo requirements:

- HICT applications should present data from a recently completed clinical trial which have not been presented anywhere previously. Although a manuscript describing the data may be submitted to a journal for consideration - this must be indicated on the submission form - it should not be published before the date of the presentation at the RSNA 2018. Clinical Trial Update applications should report additional, but previously unrepresented, analyses of important clinical trials whose main endpoints have recently been made public.

### Policies

- Submission of an application constitutes a commitment by the author(s) to present if accepted. Failure to present and register for the meeting, if not justified, will jeopardize future acceptance of applications.
- Speakers will receive complimentary registration.
- Abstracts submitted on the same trial through the standard abstract submission procedure for the RSNA will be withdrawn from the program if the trial is presented at the HICT Session.

PLEASE COMPLETE THIS APPLICATION FORM AND SUBMIT AS AN E-MAIL ATTACHMENT TOGETHER WITH:

- A. The detailed abstract should consist of up to 500 words divided into four sections: purpose, methods, results, and conclusions. Up to four references can be appended, as well as critical graphs, charts and images (no more than two tables plus three figures), which should be included in the same Word or PDF document with the abstract.
- B. The applicant must submit a letter that includes the following items: author name, co-author(s), corresponding address, telephone and fax numbers, institutional affiliation, title of abstract, and a statement attesting to the fact that the research was primarily and substantially performed by the applicant.
