As the Inspire-Innovate-Invest Campaign draws to a close, the R&E Foundation has raised more than 90 percent of its \$17.5 million objective—and with support across the entire specialty, we can finish strong and achieve our shared goal. Case in point: 2016 Cook Medical Cesare Gianturco/RSNA Research Seed Grant recipient Mubin I. Syed, MD, recently published results of a study that may help pave the way for a new minimally invasive treatment of morbid obesity. His GET LEAN (Gastric artery Embolization Trial for the LEssening of Appetite Non-surgically) study collected safety and efficacy data on the new procedure, which targets a condition that has become a worldwide epidemic.

"Our results are exciting. Radiologists are the vanguard for this procedure, which I believe will be proven effective and become the standard of care for obesity," said Dr. Syed, lead investigator of the study conducted at Dayton Interventional Radiology. "The R&E Foundation funding is critically important to the progress of this study as it allows us to continue our research and acquire additional funding to finish our work—I really think this procedure will change the world."

As research funding becomes increasingly difficult to secure from national sources, the

R&E Foundation is able to grant awards to approximately 30 percent of all applicants, giving early career researchers a solid start. In 2017, the R&E Foundation awarded \$4 million for the second year in a row. This unprecedented funding level is due to the generosity of donors to the Inspire-Innovate-Invest Campaign.



Machine Learning Grant Applications Rise as Interest in AI Grows

Experts in the field of artificial intelligence (AI) are anticipating rapid growth in applications of machine learning (ML) to diagnostic imaging over the next several years, especially those applications associated with specific forms of "deep learning" such as convolutional, deep belief and recurrent neural networks. These new applications hold the promise of further increasing the diagnostic and quantitative efficacy of our imaging tests, as well as the promise of greatly facilitating the work of the radiologist. This technological innovation will undoubtedly transform radiology over time.

Radiologists should assume a leadership role in the development and application of machine learning algorithms to diagnostic radiology. By providing grants for scientific research and education, the RSNA R&E Foundation provides a venue for those investigators and scholars who wish to pursue exciting and innovative projects, typically by exploring new applications of current technology, developing new technologies or exploring new disciplines.

Over the last four years, the number of grant applications involving artificial intelligence has increased significantly and it is highly likely that this trend will continue. The R&E Foundation is funding projects that will help guide the way for humans and machines to work in mutually beneficial ways, thereby leading to a future in which this technology continues to serve the needs of expert radiologists, referring clinicians, and most importantly, patients.

The 2017 ML/AI grants cover a wide variety of topics, including:

- Evaluation of Quantitative Cardiac Function and Volumes With Single Breath-hold Volumetric Cardiac MRI and Deep Learning Segmentation
- Development of an Automated Liver Imaging Reporting and Data System Using Deep Machine Learning
- Automated Neuroradiologic Diagnosis Using Customized Advanced Image Processing Algorithms and Bayesian Networks
- Machine-learning to Predict Risk of Upgrade and Recurrence of Ductal Carcinoma in Situ

Although most practicing radiologists are not currently involved with machine learning algorithms in their daily work, major academic institutions and radiology societies have already taken notice of this major trend, and have set up partnerships to explore the potential of artificial intelligence in diagnostic radiology. Radiology societies have begun to offer educational presentations on the topic of machine learning. In addition to refresher courses and educational symposiums, the 2017 RSNA Scientific Assembly and Annual Meeting will feature a Machine Learning Showcase on the Technical Exhibits floor and a Machine Learning Community in the Learning Center.


on Tuesday, November 28, at 6:30 AM from Arvey Field in Grant Park.



Truly VIP: Private Practice Groups Boost Foundation's Campaign

Over a dozen years ago, the R&E start of Foundation debuted its Visionaries practice in Practice (VIP) Program as a mechanism for private practice groups to support the Foundation. What began with 10 practice groups donating a total of \$190,000 in 2005 has grown into a vital source of research and education grant funding with upwards of 35 practice groups donating a total of \$500,000 annually.



Latest Award Brings Subsequent Funding to \$50 Million

When donors gave to the R&E Foundation in the 1990s, would they have ever contemplated that a Research Seed Grant would result in \$50 million in subsequent funding twenty years later? This is the kind of return on investment being realized by those early supporters who funded the research efforts of **Zahi A. Fayad, PhD**.

Dr. Fayad received a 1998 RSNA Research Seed Grant for his project, *Non-Invasive MR Characterization of Atherosclerotic Plaques in Human Coronary Arteries.* Today, he is principal investigator on a study that has been awarded \$13 million from the National Heart, Lung and Blood Institute of the National Institutes of Health (NIH). In this current project, *Stress and Atherosclerotic Plaque Macrophages – a Systems Biology Approach*, Dr. Fayad aims to uncover the

mechanisms by which stress contributes to cardiovascular risk through a five-year research program. This NIH award brings Dr. Fayad's subsequent grant funding as principal investigator to \$50 million.

Dr. Fayad is the Mount Sinai endowed chair in medical imaging and bioengineering; professor of radiology and medicine (cardiology), and director of the Translational and Molecular Imaging Institute at the Icahn School of Medicine in New York, NY.
